These companies and websites are UK based, but the data collected and processed can be worldwide. As well as direct data collection through the companies and website communication this policy also covers data collected by telephone, email, face to face communication (inclusive of business cards), social media, and our Kiosk License System.

3. Collection of Personal Data

Below are the reasons and purposes for which we collect data.

- To enable us to contact someone who has expressed an interest relevant to products or information that we offer.
- To offer further information and discussion regarding subjects of interests
- To enable us to provide the required service, and supply products requested
- To fulfil a contract between us and clients
- To complete purchase transactions on a financial basis, and bookings
- To ensure websites are running correctly and enable us to observe business infrastructure
- To manage communication between us

4. Lawful basis for the processing of personal data

We never collect data to sell on to third parties. Data collected on events is sometimes used for either The Racing Bug and/or our sponsors sales and marketing. In this case participants are made aware and have to have consented for this to happen. The table below shows which data is collected for each purpose.

5. Storage of personal data

The Racing Bug Ltd and other companies under the umbrella are all UK based inclusive of websites.

Personal data files used within the business are on shared documents accessible by multiple computers. These can only be accessed by authorised staff within business offices. More sensitive information is held by the data collector only and is either securely stored (if physical documents) or password protected electronically. Data accrued on system kiosk is also encrypted.

As part of staff contracting and company policy and procedures, client/participant details are confidential, and actions are taken if breeched.

6. Data Security Measures

We take great in care in ensuring personal data is not accessible/ given to those unauthorised.

- Data kept on computers/online is appropriately and securely password protected
- Shared data is only accessible locally within business locations
- Physically files are stored securely i.e. locked storage
- Data collected on our kiosks are only locally accessed and are NOT uploaded/accessible online, therefore no chance of being intercepted.
- Unused/unneeded data is destroyed appropriately and regularly.
